**Sub: Filling up the posts of AAO in the Pay & Accounts Office, M/o Rural Development, Krishi Bhawan, New Delhi in the Pay Scale Rs.9300-34800+4800(GP) on deputation basis.**

This is in continuation of this office Circular No. PAO/RD/Admn/Circular/Deputation/2016-17/2931-41 dated 09.11.2016 on the subject cited above.

2. Two vacancies of Assistant Accounts Officer(AAO) are vacant in the Pay & Accounts Office, Ministry of Rural Development, Krishi Bhawan, New Delhi-110001 in the pre revised Pay Scale of Rs.9300-34800+4800(GP) of PB-II(Now revised to Rs.47600 as per Level 8 of 7<sup>th</sup> CPC Pay Matrix) which are proposed to be filled on deputation basis from amongst the officers/officials holding an analogous posts or have experience in cash and Accounts and have passed Subordinate Accounts Service Examination- AAO(Civil). The applications of the interested and eligible officers/officials who can be relieved immediately may be sent to **the Sr. Accounts Officer(Admn.), Room No.348, C-Wing, 3rd Floor, Ministry of Rural Development, Pay & Accounts Office, Krishi Bhawan, New Delhi-110001, Contact Number: 23097030, Email-id: ritu.adhikari@gov.in/sunita\_aao@yahoo.in** within 30 days of issuance of this vacancy circular alongwith their bio-data in the prescribed proforma(Annexure-I), necessary vigilance clearance and ACR's/APARs for the last 5 years duly completed in all respect. The applicants will not be allowed to withdraw their candidature at a later stage and incomplete application in any respect will not be considered. The interested applicants can also send advance copy at the above address, so as to enable this office to follow up with the cadre controlling authorities.
3. The eligibility conditions to apply for the said posts are as under:-
  - (i) Officers/Officials working under Central Government/State Government/UTs
  - (ii)The Officers holding analogous posts on regular basis; or
  - (iii) With 5 years regular service in PB-II (Rs.9300-34800 with GP Rs.4600); Or
  - (iv) With 3 years regular service in PB-II (Rs.9300-34800 with GP Rs.4800) and passed an examination, equivalent to (AAO(C)Exam conducted by the accounting organizations under the Central/State Government.
  - (v) The maximum age limit is 56 years as on the closing date of the receipt of application. Applications of above 56 years age limit will not be considered.
4. Terms of conditions:-
  - (i) The Pay during deputation period shall be governed by the usual Term and Conditions of deputation prescribed in the DoP&T O.M. No.6/8/2009-Estt.(Pay-II) dated 17/06/2010 as amended on 17/02/2016
  - (ii) The deputation period will be initially for three year, expendable to 5 years as per norms of DoPT from time to time.
