Dear Colleagues,

You may be aware that Performance Review are being organized at least twice during the year. It provides us with an opportunity to take stock of the progress of the programmes, emerging issues and strategy ahead. It is in this context that we propose to organise the **Second meeting of the Performance Review Committee (PRC) for the financial year 2020-21 on 3rd February, 2021 through virtual mode.** As the review of annual plans would soon follow and in most of the States, legislative session may be going on, therefore, we propose to wind it up in a single day itself.

In this meeting, as has been the practice, all the major Rural Development programmes, including PMGSY, MGNREGS, NSAP, SPMRM, SAGY, PMAY-G, DAY-NRLM, DDU-GKY and DISHA would be reviewed followed by active discussion as per the **enclosed** programme schedule. The idea is to understand reasons of differential performance of different States/UTs and come out with road maps for achieving the programme objectives in a time bound manner. Identification of best practices would be the running theme. I would request you to discuss this matter with respective Programme Division Heads in this Ministry, so that 2-3 best practices get identified for crisp presentation by States/UTs.

3. I request you to personally participate in this consultation along with the Commissioners/Directors (Rural Development) and the Mission Directors of the State Rural Livelihood Missions (SRLMs). Do also communicate to the Secretary, looking after Pradhan Mantri Gram Sadak Yojana (PMGSY) and National Social Assistance Programme (NSAP) to enable their participation in this meeting.
